1) Call to Order By Superintendent Mark Schutzer at 7:31 pm.

Executive Reports

a) Superintendent: Mark Schutzer (Written copy of Mark's report attached)

<u>BOO Minutes</u>: Mark solicited comments on how the new "minutes approved via email" system went. Everyone seemed to think it worked well enough, except for Darrell who was aware of numerous errors he submitted.

<u>Convention Items</u>: Bob said that he had not contacted Tom Blinn concerning the bank account. Coast Division has not received a surplus split from the 2009 PCR Convention. There are no further open issues concerning the convention, and that Tom Crawford has posted a comprehensive post-convention report online.

<u>Volunteerism:</u> We need more help at the meets to help Darrell with guests and first timers. Darrell said that his Registration Desk duties, helping Ted had prevented him from doing a lot of 'hosting' of guests/first timers, but several members had stepped up and supported that effort. We will pass the word for others to help on an as needed basis. Mark is still looking for help with the TimeSaver Switching Contest, since Dave Loveless cannot make every meet. Open discussion of some membership recruitment and retention ideas; Pat said that there has been a Yahoo group discussion on building a small layout at GTE or other events, and giving it away or perhaps a raffle. No action was taken.

<u>Meeting Sites</u>: There was a discussion on meeting sites, with confirmation that the next two meets were as advertised. The Certificate of Insurance will be available in late November and Mark will contact NMRA HQ or Ron Plies to get a copy to be forwarded to Don Short for Buchser School.

b) Chief Clerk: Darrell Dennis: John Sing asked that a place in the Committee Reports be added for Webmaster. It is listed now as item **g)** xii).

- **c) Paymaster: Bob Ferguson:** Income \$1,624.69, Expenses \$1,419.90. Net Income \$204.79. The convention monies are still an open item and are not included in these totals.
- **d) Director: Rod Smith:** The PCR Board will meet October 24rd 2009, in conjunction with the Silver Rails Convention meeting at the Nugget in Sparks, NV. If anyone wanted something to be brought up please advise Rod. One subject on the table will be lengthier data cables between the computer and projectors for clinics.

5) Standing Committee Reports

- a) **Auction: John Marshall -** John reported that the last Coast Meet auction ran well, but was understaffed. We need to find help in this area also. A lengthy discussion was held concerning the auction numbers for brass items, and or high value items. A vote was taken; leave it as it is now or make a change in the numbering of the brass items. The vote was 4 to 2 to leave it as it is now, brass items will continued to be numbered 1 through 25.
- b) Auction Accounting: Bill Swindell Bill noted a higher than usual number of buyers wanting no-bid items during the auction, causing delays. The Fee will be modified to be \$1.00 for all minimum bid amounts under \$10.00, then 10% for all amounts over \$10.00 and over. (Bill noted that the minimum bid for any item was \$1.00). Bill moved that the entire "no-bid fee" be retained by the Division and not added to the sellers payment. After discussion both motions passed unanimously.

Some Feedback/A Suggestion (I'm Not sure where this belongs in the agenda):

Tom Van Horn told me several First Time Coast meet attendees asked him after they attended their First Coast Meeting: Why do we have to sit through several hours of auction we aren't interested in for the door prize drawings?

I would like the BOO to consider holding Only the Free Door Prize drawings right after the Business meeting ends. I think Most people who are willing to Purchase raffle tickets are also willing to wait for a later drawing.

But if we want to encourage 1st Timers to come back, we could let them leave the first time without requiring they sitting through the Auction. I really think any one who wants to bid WILL stay, but I also think most 1st Timers may not have expected to stay several hours-after all, they are 'testing' out our meeting and may have other commitments.

I also know a couple new attendees brought models to display/share and left early the last time we met at CHM, but I want to give more people time to vote and more time to try the Timesaver, so i don't want to suggest we move announcing those results earlier at this time.

I'm Sorry I'll miss seeing you all tonight. I hope you have a good meeting. Steve


