Super indent's Report By Phil Edholm March, 2021 Divisional Update

Superintendents Report



It appears as if spring is here, at least by the temperature on the day I am writing this. The good news is that Covid cases are down, vaccines are up, and the end finally appears to be in sight. A couple of counties in the Division have moved to a more lenient tier and clubs and layouts are reopening. But, with the cancellation of the physical meetings of both the PCR convention in Fresno and the NMRA convention in Santa Clara, the end is still a way off. Of course, both conventions will proceed virtually, but not physically this year.

Until face-to-face events return, we will continue to have our semi-weekly Coast Virtual Events and there are great virtual events being planned for both the PCR and NMRA conventions. If you are interested, there are several volunteer roles available in the on-line convention and opportunities for doing clinics and a tour of your layout.

Looking forward, while the end is in sight, the timing of returning to in-person events is a bit murky. The optimistic view is that we might be able to have in person meetings in Q4, the pessimistic view is probably early 2022. In either case, the in-person event world we will return to is going to be very different than before. Even prior to Covid, there were changes that were driving the division to rethink our event strategy. Several issues have emerged with our pre-Covid quarterly physical events and auction program.

1. The need to host the auction as a "for profit" event limited the venues we can use and increases the venue pricing dramatically. We were fortunate to have two great venues for the last years. Unfortunately, the Elks were already increasing the monthly rent before the pandemic. This combined with a general decrease in the auction revenues and Coast percentage had made the Elks events unprofitable and the Boy Scouts only slightly profitable. Unfortunately, the quality and value of items at the auction has decreased on average as higher priced items went to eBay for sale. The auctions have traditionally paid for the quarterly events and returned some cash to the Coast reserve fund. Prior to Covid, rather than the auctions and events adding to our reserve fund, we were rapidly approaching a point where we would be funding the events from the reserve, decreasing it over time. Running a deficit budget is not something the board believes is a good path forward.

2. Another issue is the auction team and software. We have been able to run our auctions as a rapid-fire stream of items based on a combination of a dedicated team of auctioneers and accounting volunteers as well as a custom software package that enables the process. Unfortunately, the software is aged and needs maintenance/rewriting at some point. It is a Visual Basic program (if anyone is interested in volunteering to take it over). The other issue is the auction team. Multiple members of the team have served faithfully at Coast events for many many years, arriving for every event early and leaving late, working throughout the event to make the auction work. The division thanks the auction team for their service. However, due to a combination of advancing age and extended time doing the role, the auction team is going to lose many/ most of the members soon. To continue with the same auction format will require a new set of volunteers.

3. The third issue that emerged in 2020 is the impact of the Boy Scout bankruptcy. As part of the bankruptcy and the liquidation of assets, the Boy Scouts are selling their San Leandro headquarters. This removes this facility as an option for future Coast events, leaving us with only the Elks for auction events. We will have to research new venues for both an auction and potentially non-auction events.

4. Clearly, the division must decide how to proceed when we can. We have multiple questions to decide about returning to in-person:

- Do we have 2 or 4 auctions per year?
 - 4 auctions as before with a new venue?
 - 2 events including an auction at the Elks, 2 events at other locations in the Division without the auction stipulation? Locations can vary for each non-auction event.
- Where will we hold our events in the future beyond the Elks?

• Do we continue with the current auction process or move to another live auction mechanism (silent auction, new tool, ?)?

- What other activities should we have at our physical events?
 - More Clinics and sessions?
 - Local layout tours?
 - Operating sessions (both active and observers)?
 - Modular groups?
 - ??
- How do we reconcile facility costs with auction revenues and other costs? Options include:
 - Increasing auction lot minimums (from \$1 to \$2-5)
 - Increasing the Coast fee percentage at auctions
 - Use low-cost facilities (library, community center) for two events per year without an auction
 - Having a suggested donation at events
 - Institute a paddle charge

While the virtual events have proven their ability to keep us together, I believe in-person events are the backbone of the NMRA and the general fellowship of Model Railroaders. The ability to share our efforts, see models/photos and interact and see details in clinics and in-person cannot be replicated virtually. Ours is a physical and detailed hobby. For these reasons, I believe we need to define our path forward to enable the largest percentage of the Coast membership to have the option to attend an in-person Coast event and the right programs/clinics/tours/etc. to make it worthwhile.

The good news is we have some time to plan how we emerge from the Covid lockdown. To plan for our future, I would suggest we convene a committee of Coast members to consider the options and make a recommendation to

the Coast Board. The focus will be how we should organize and the processes/activities in our in-person events and also our virtual events post-Covid. I am hoping we can get a reasonable sized group to participate and work on the planning and research (where can we meet?, what auction options are there?. etc.). I am proposing to begin the committee meetings in late April (after the April Board Meeting and Tax Day !).

If you would like to participate in defining the future of Coast in-person events, please contact me by email. I will build a list of committee volunteers to review with the board in April and we will begin our discussions and planning in late April. Any member interested should join in. This should give sufficient time to develop a strategy and review with the Coast board for new in-person events in late fall/2022. For all Coasters, this is your opportunity to be heard about what excites you and participate in planning our future events. Please participate.

Finally, if you have not joined one of our Saturday Coast Virtual Events, do drop in. On March 6th at 9 AM we will be having the Coast Division elections, but more importantly, Frank Markovich and Mike Blumensaadt will do an eClinic on the layout they built for the NMRA exhibit at the California State Railroad Museum. They will discus the goals, the challenges, and how they made it all happen. Their layout is intended to show the process of building a model railroad and feature commercially available products that show how easy it is to get started and still build amazing results. This is a great Coast eClinic topic to join for the first time. It will be a great preamble to a visit to the NMRA exhibit when the Museum opens later this year. Also, other Coast members have worked on the exhibit and may discuss what is happening. Not to miss for sure!!!! BTW, if you miss it, a recording will be on the Cost Division YouTube channel here:
