I'm excited about our Suntan Special Convention in Santa Cruz, May 2-6, 2007 at the UCSC Inn!

Full Registrations for the Suntan Special will be \$95 during River City Express in Sacto, then will be \$105 until January 31, 2007, then will be \$115 until the 2007 convention ends. This is a Deal-- if you enjoy riding trains: Full Registration includes Saturday's Special train to Roaring Camp & Big Trees from the Santa Cruz Boardwalk AND the return train to SCruz PLUS the Banquet at Roaring Camp AND the steam train rides to/from the Summit, with raffles for cab rides!

Other registration options: Saturday Only (includes train rides & dinner) for \$70; Spouse (all week) for \$70; Saturday Dinner only (intended for other family members): \$60; Daily Registration(W/Th/F): \$35. Checks or PayPal for payment. Website should be up May 1st, at www.PCR2007.org. Our Convention Car will currently be a Granite Rock car.

Prototype (and Layout) tours being planned include: Granite Rock on Thursday, Davenport CEMIX plant on Friday, Martinelli Cider/Birds-eye Frozen Foods on Saturday. Although I have Jim Vail's DVD of his 1970's 2 minute video of the Davenport Plant's Narrow Gauge Electric Railway (the only known video), I've wanted to see the Davenport plant for 30+ years and this is my(our) chance to see whatever replaced those trains. Layout tours should include many from San Jose to south of Santa Cruz, including many fine layouts I've seen and hopefully many I haven't seen, yet!

We've reserved 100 rooms at the Inn for \$95 a night, including Full Buffet Breakfast (NOT "Continental"): the UCSC Inn also houses students on the meal plan, and 4 years of their breakfasts was always fine by me.

Auction Accounting by Bob Ferguson

At the Coast Division Board of Operations meeting, the subject of auction item security and sold item pickup was discussed at length. Several changes will be made as a result of problems encountered recently at the meets.

1. The 10 item limit will be enforced. This is not a limit on the number of items that can be entered into or purchased from the auction. It is the number of items you have committed to purchase and which are stacked together on the stage or tables behind the auctioneer. When you have reached 10 items purchased and not picked up, come forward to the auction cashier, pay for the items and remove them to a secure location of your choosing. Once you have paid for your purchases, the auction accounting committee and the Division are no longer responsible for their safety. If you do not come up and claim your items when the 10-item limit is reached, the auction will be stopped and you will be asked to settle your account. The auction will not resume until your transaction has been completed. This will include the members working on the auction committee. Avoid this by keeping track of how many items you have bid on and won and come settle up regularly. If you intend to pay by check and purchase a lot of items, bring several checks as we will not be "banking" your items for payment on a single check.

The checks tendered for payment are always made "Pay to the order of CASH" so that we can use them to pay the sellers. Even though you may have bought a lot of stuff, chances are that not all that stuff was entered by the same seller and we therefore need to have checks in amounts that can be used to pay multiple sellers. No check will be accepted for more than \$300. If your total bill is \$725, be prepared to write 3 checks when you pick up your items. Of course, cash is always an acceptable form of payment! You can avoid the hassle of checks by going to the bank on Saturday and withdrawing cash to bring to the auction in lieu of checks.

- 2. The area behind the auctioneer is not a lounge for non-working auction committee or "Officials". The space is limited and the entire length of the stage area is used to spread out the sold items until they are picked up. People who are just standing around in the area present a hazard to those who are handling the items, especially when picking up stacks of items to take up to the cashier. Please do not use this area to chat or lounge. Find a chair away from the working area and enjoy the auction.
- 3. At the end of the auction, the head tables will NOT be taken away until all of the purchased and no bid items have been picked up. All persons, except the auction accounting crew and runners, will be asked to immediately depart the area behind the tables and the end of the head table area which was previously open to the room will be closed off with the last auction items tables.
- 4. No one will be allowed to pick up his or her own items from the sold area. Even if you are on the Auction Committee, you will need to get in line with everyone else to claim your items. It will help to expedite the closing of the auction if all sellers would allow the buyers to come up first and purchase their items so that we can handle the sellers just once when they cash out. Perhaps the sellers could help the site host with the cleanup and table/chair stacking while the buyers are handling their transactions.

I know that these concerns and the associated measures sound a little draconian, but problems in the recent past have necessitated these changes. If we all work together and keep track of our purchase progress throughout the auction, these measures will be inconsequential to most of us. I would like to thank everyone in advance for their understanding and concurrence.





