And, If they enjoy it, they may come back. Their decision, not ours.

I know that like most of what I write, I am writing nothing new here: I'm pretty certain it has all been tried before. I just want to suggest each of us try putting ourselves out just a little bit by talking to a friend, or an interesting or pleasant stranger you may meet in a train store, and invite them to the next Coast Meet. I think there is no more powerful form of invitation than a personal one. It is hard walking into a room of total strangers for many of us. Offer to pick them up & give them a ride & to introduce them to some of your friends at the meet You think they may enjoy. Remember, we all share with this new person as a minimum some common interest in trains. Maybe they will come back again, or maybe they won't. But they won't know what they are missing unless they try coming once. You could even invite someone you know who thinks NMRA isn't worth it. Perhaps after they come and maybe have some fun, they will change their mind. Try it. Please think about it. Some stranger you invite may bring a wealth of new skills and ideas, but we may never know until and unless you invite them.

### Registrar's Report By John Ameling

At the March meet we had 92 attendees: 81 from Coast Division, 6 from Redwood Division, 1 from Sierra Division, 1 from Daylight Division, and 1 from Other (I never heard of it either). There was 1 guest. This was down from the typical 110 we have had recently.

We had 12 door prizes and 7 raffle prizes The raffle prizes included \$225 in gift certificates, and the book "Napa Valley Route" The raffle income was only \$1.26 per person, as opposed t a more typical \$1.50.

We will be looking at alternatives to increase our prize options.

### **Elections**

At the March Meeting we elected the Superintendent, Chief Clerk, and Treasurer.

Dave Connery was sick , so Rod Smith took off his bridge structure reporting hat and put on his alternate ego as Dave's nominating committee backup. The nominations for officers from the committee were:

A request for nomination from the floor was met with a deafening silence, and the railroad job was completed by Pat LaTorres moving that the slate be approved unanimously. Jerry Wilson seconded this blasphemy and it was approved before any dissidents could interject.

### Auction Report By Bill Burket

The March meet brought out a little over 500 items of which 34 were brass. This was a very good showing. I am hoping for just as good or better turn out of items for the June meet.

Also, I brought a guest who attended for the first time. If all of us could come up with one guest it would double the attendance. I don't think this is impossible, rather something that takes a little effort. You never know what you may find.

At the December meet I bought two books that I had been looking for for over ten years! I usually don't get the word on estate items until after the Dispatcher goes to print. So bring a guest, come for model railroad fellowship and a good time. See you at the June meet!

#### Transition Committee Report By Tom Crawford

Last year Bill Burket came to the Board of Directors meeting and said that he needed to prepare someone to take over the auction, since he has been on the committee for closing in on 40 years and he wants to retire from it. As we discussed it, we came to the conclusion that we really didn't have a transition plan for when people leave their jobs for any reason. In Bill's case, we have time, but we realized that we need to be able to consider all possibilities. What happens if you intrepid editor gets run over by a train tomorrow and no one knows what to do.

An even worse situation would occur if someone like Bill Swindell, who is responsible for our auction software, would get hit by this proverbial train. (or more likely get killed in a car accident) How about our Treasurer, who is the only one who has access to our money?

You get the picture.

This was really brought home when we heard that Bill Swindell and Bob Ferguson were not going to be ay the June meet due to other commitments. We panicked. It turns out that the situation changed, but this really brought home the point that this hypothetical train had many faces, and the threat was very real.

So the Transition Committee was formed. It consists of Tom Crawford, John Sing, and John Ameling.

Our task is to make sure that each position in this division is documented and the information and tools are available for us to recover after the loss of anyone in a leadership position in the division, with no warning.

This committee has documented 5 positions so far, and at the March meet we started working on documenting the Auction Accounting functions. This also involves training people to take over the tasks done by the auction accounting committee members. If we do it right, we can even have people give these very hard workers a break every once in a while. I did a stint doing Bob's job at the last meet, and it is REAL easy to make a mistake which can cost us significantly. Making sure someone else can fill in doing the job accurately very quickly during the rapid fire operation of the auction, is mission critical.

We will keep you posted on our progress.


