## Wanted: Meeting Site(s) By Steve Wesolowski

Q: Doesn't Coast Division have meeting sites? Are they going away'?

A: Yes and No: we meet at Buchser School & the Computer History Museum. Those connections are strong., but we could use more.

Q: Why? Is there a problem?

A: Today we have no problem/both sites are available because of a Coast member's relationship with them. But relationships change: after a member retired and moved the CA School for the Deaf became unavailable, but luckily CHM became available.

But because both the locations we currently have access to also have others who may want to use those sites, conflicts may arise. In those events, the group that has the closest ties to the location (one of their own events) or the event which offers the most remuneration (most likely not the Coast Division) will get to use the site. This would require the Division to either shift the date of the Meet or find an alternate (abet more expensive) meeting site.

And both sites are in Santa Clara County, maybe

less desirable for Alameda, Contra Costa, San Francisco, San Mateo and Santa Cruz County members. Meeting outside the South Bay some times would be easier for some and might increase attendance. Members are free to move and lose their connection:then a site may become unavailable, or unaffordable without an insider's discount. When money is tight, any venue may raise their fees beyond what our division can afford. Most organizations, including ours, must meet to achieve their goals. Finally, since both current member contacts will someday leave, our Division must eventually find meeting places we can afford.

Q: What are our requirements?

A: -- Parking for 50 plus cars, with Good Disabled Access (also for equipment and auction items hand carts).

-- A Large Room seating 100+, including a couple dozen auction item tables, and enough room for the tables

-- Two (preferably Three) rooms or areas suitable for presenting clinics to at least 20-30 people each.

-- AC power available, bathrooms nearby, plus an area for volunteer food vendor use would be great.

-- Available Saturday or Sunday, from about 8AM until about 5PM.

-- Coast Division is insured through NMRA; a Certificate of Insurance is available.

-- Coast currently donates \$150 per meeting; significantly more may mean charging for attending, which we prefer to avoid.

Q; Who should I contact to ask if a location is suitable? A: John Marshall, Tom Crawford or Bob Ferguson all know our requirements and are listed in the Dispatcher and Branchline.

Thanks for listening and helping us find more meeting sites.


