The Evolution of the Coast Dispatcher

As most of you are aware the attendance at Coast meets has been dwindling and our income from the auction is declining. Your Board of Operations met on October 10th and reviewed this year's finances up through the end of September. We discovered what we all suspected; the auction income is no longer sufficient to cover our current expenses.

The income / expense sheet for the Coast Division is pretty simple; on the income side we have the auction proceeds, raffle income, and a \$1 dollar per year per member rebate from the national organization. Our expenses include meeting site costs, raffle / door prizes, and the Dispatcher costs.

For the first three quarters of 2011 our expenses are running about \$250 dollars per quarter more than our income. For this year so far we are in the red for over \$700 dollars. Our biggest expense is the Coast Dispatcher as it costs about \$500 dollars per issue for printing and mailing costs.

While the Coast Division has healthy financial reserves we cannot continue to operate at a loss. At the Board of Operations meeting we discussed how we could remedy the situation. The only feasible solution was to make the Dispatcher an online newsletter. To advise every one of upcoming meets, a postcard will be mailed containing the normal information about the location, a map, the meet schedule, clinic subjects, contest categories, and any other information that will fit on the card.

This will be the last printed version of the Coast Dispatcher. Prior to next year's March meet we will transition over to the postcard notification. Converting to a postcard notification and online Dispatcher will save the division over \$300 dollars a quarter and will bring our expenses back in line with our income.

There are some advantages to having the Dispatcher as an online newsletter. The online version will be in full color and will be free to have more pages of content. We can and will welcome articles for publication from you authors looking for credit toward the Model Railroad Author achievement award.

The on-line Dispatcher will be posted on the Coast Division web site as it is now. You may join the Yahoo Group (http://groups.yahoo.com/group/Coast_Dispatcher) if you would like an email notification with a direct link to each issue online.

The board discussed several different possible solutions to the problem. Some ideas that were discussed included charging entry fees to meets, charging a subscription for the Dispatcher, and several other ways to improve the situation. By far our largest expense is the printing and mailing costs for the Coast Dispatcher. After a good discussion the board decided that in January we will convert the Coast Dispatcher to an online newsletter. To keep the members informed of meets we will send out a postcard which will include all the details of the upcoming meet. Converting to the online format will save us over \$300 dollars a quarter and bring the finances back to a net positive.

And in keeping with the “times are a changing” theme I hope I see all of you in December at our new meeting site in San Leandro. This is a chance for all you East Bay members to attend a meet in your own backyard.

With the Yosemite Valley Shortline, the Bay Area Z Boyz and other modular groups there, there were more than a dozen other 'old' Coast Division train friends at the Richmond GTE show I knew there: Rod Smith, Charlie Getz, Ronnie & Pat LaTorres, Jim Eckman and several others stopped by to visit and help answer questions.

Sunday was Michael Marriner's 1st time volunteering, after attending his very first Coast Division Meet

in September! Before Sunday, Michael emailed me he wasn't sure, as a new NMRA member, what questions he could answer. I replied that sharing his interests & enthusiasm with those who stopped by our tables was plenty. We all enjoyed getting to know Michael better and learning about his train interests. As always, I learned some more stuff about trains and other important stuff in life talking with Michael.

Craneway Pavilion in Richmond was built in the 1930's as a Ford factory with mostly natural lighting (lots of windows). It's the most beautiful train show location I've ever enjoyed, with its lovely views of SF Bay, plus sail & power boats cruising by only a few feet away, creating very nice visual breaks even from watching model trains.

Besides the many boats we saw, several industrial shortline yards, working sidings, and even a container port were within 5 minutes drive of the pavilion, along with the beautiful Golden State Model Railroad Museum in Point Richmond, with 10,000 square feet of World Class modeling in most of the gauges and scales I enjoy modeling in (those I can't also ride on), including On30, N, HO_{n3} and others.

Steve Peters and I visited the Golden State Museum on Saturday, the first time for both of us, and we agreed we wished we lived closer than Santa Clara Valley, so we could both more easily join and enjoy it more often. What a wonderful layout! We both encouraged everyone we spoke to Sunday to visit the museum, too.

If you want to enjoy even more train fun than you already enjoy just attending Coast Division meetings, consider joining other volunteers at International Railfair, November 12-13 in Roseville (contact Mary C. Moore-Compagna) and/or at the Great Train Expo (Contact Darrell Dennis) in San Jose, November 26-27.

Although Volunteers also receive Free admission, your biggest reward likely will be enjoying trains with other volunteers and the others you meet. We'll be glad for your company, and you earn credit towards your Association Volunteer AP Certification.

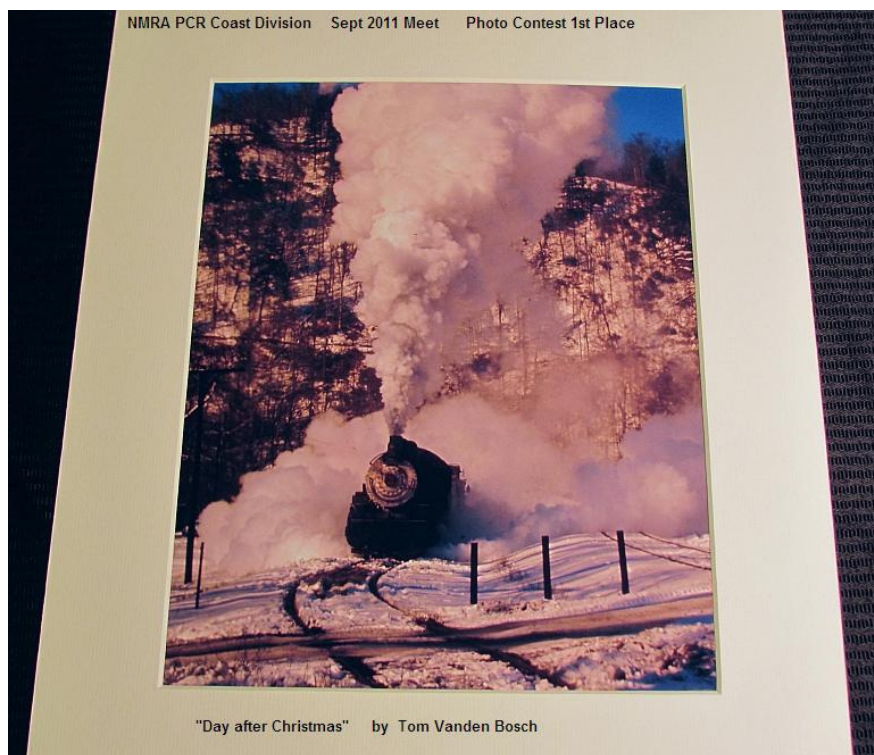

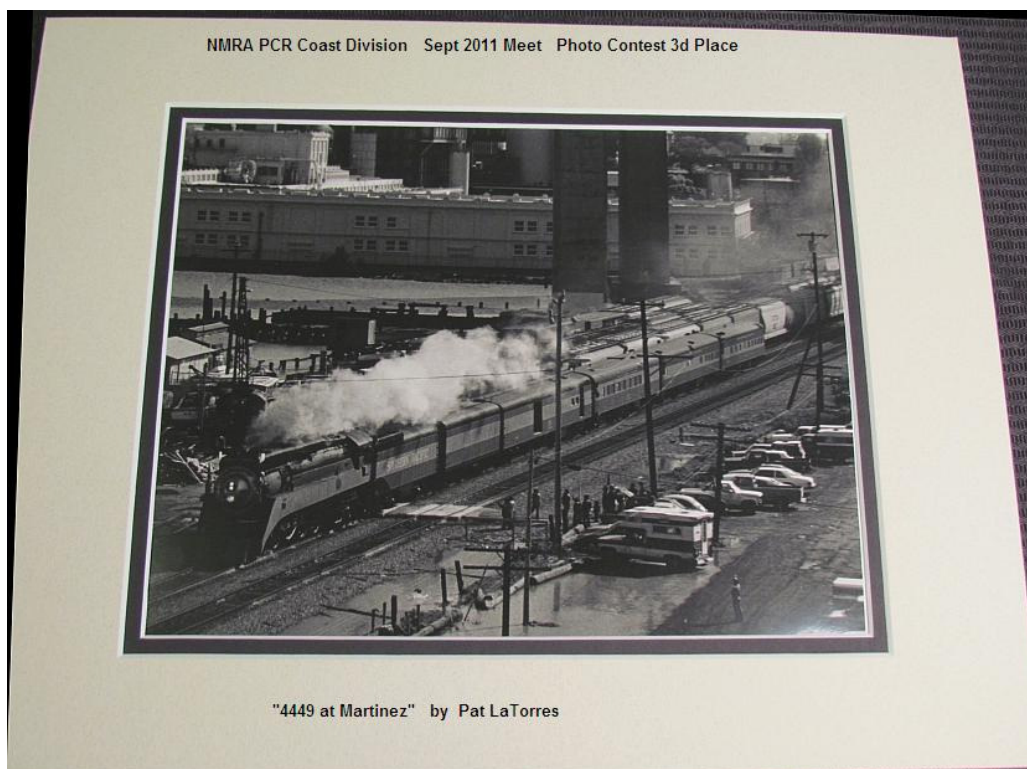

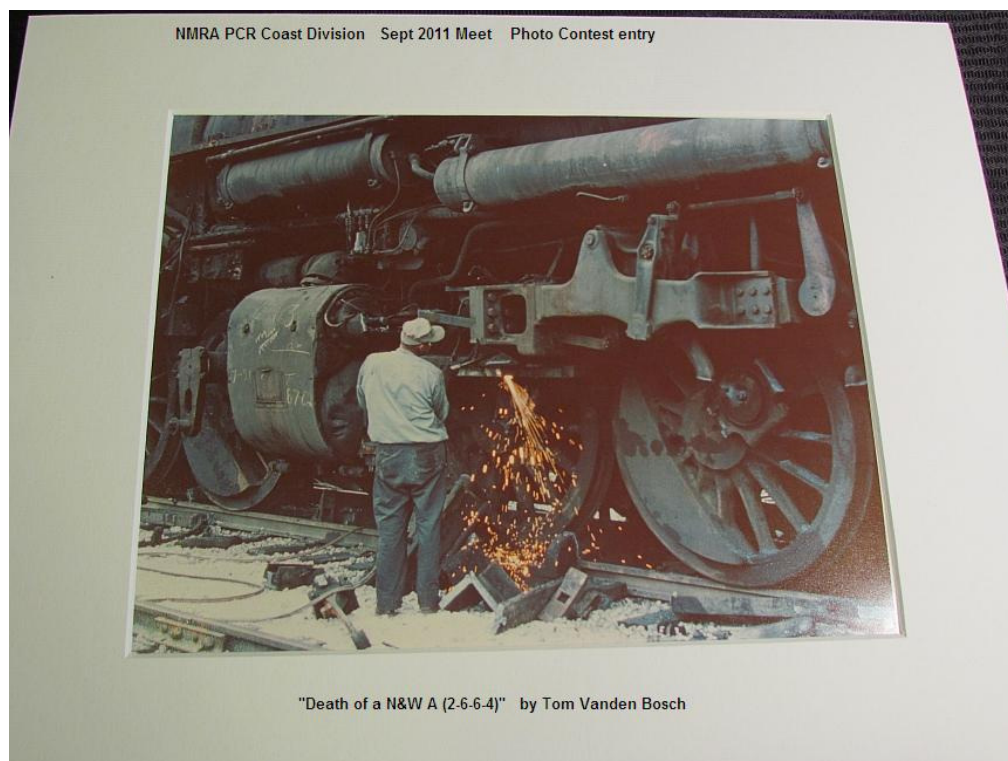

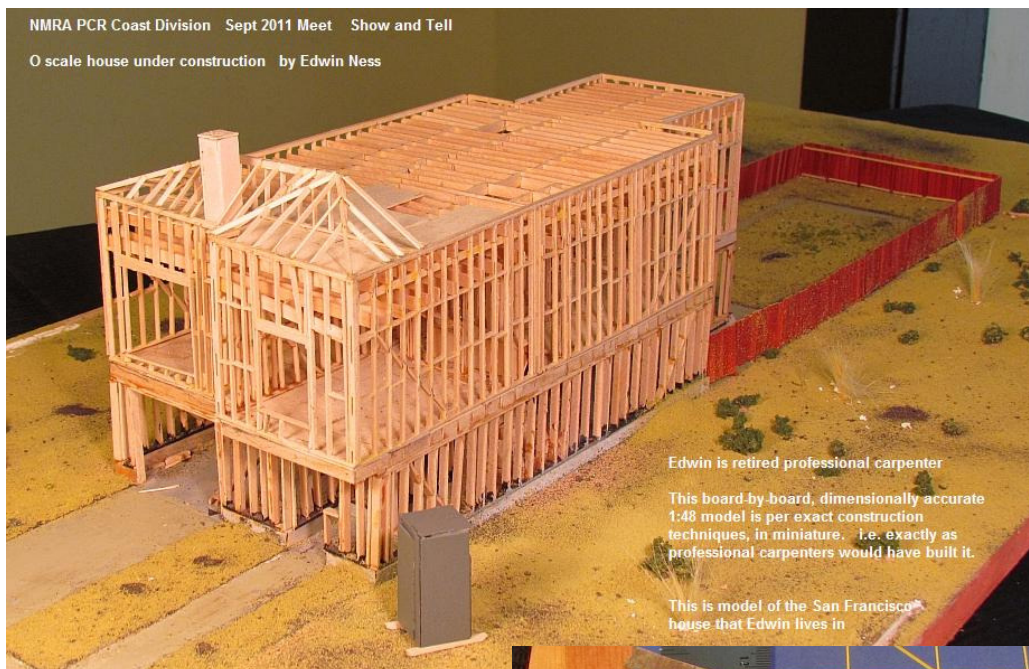

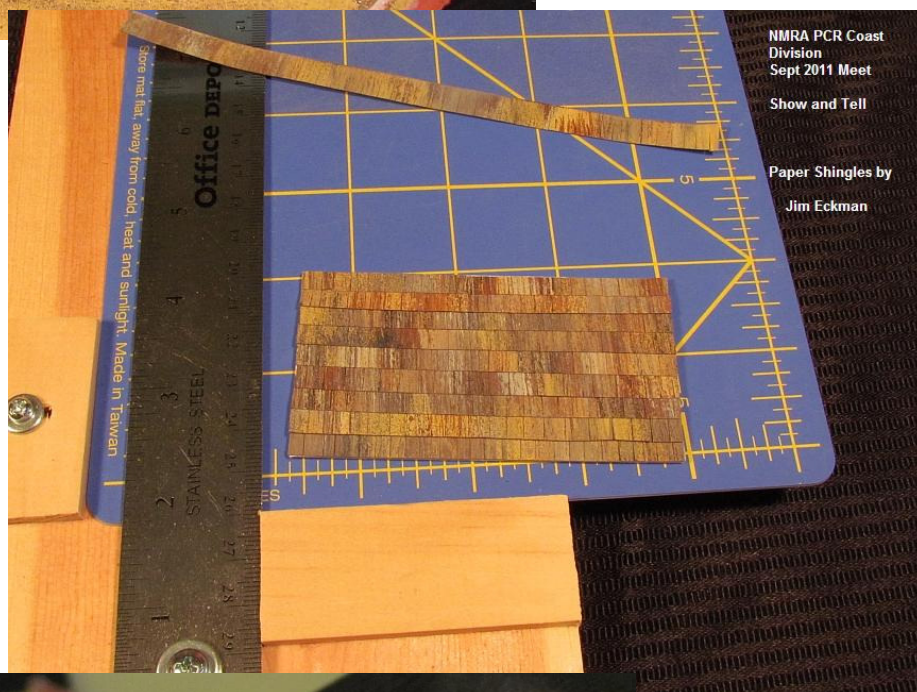

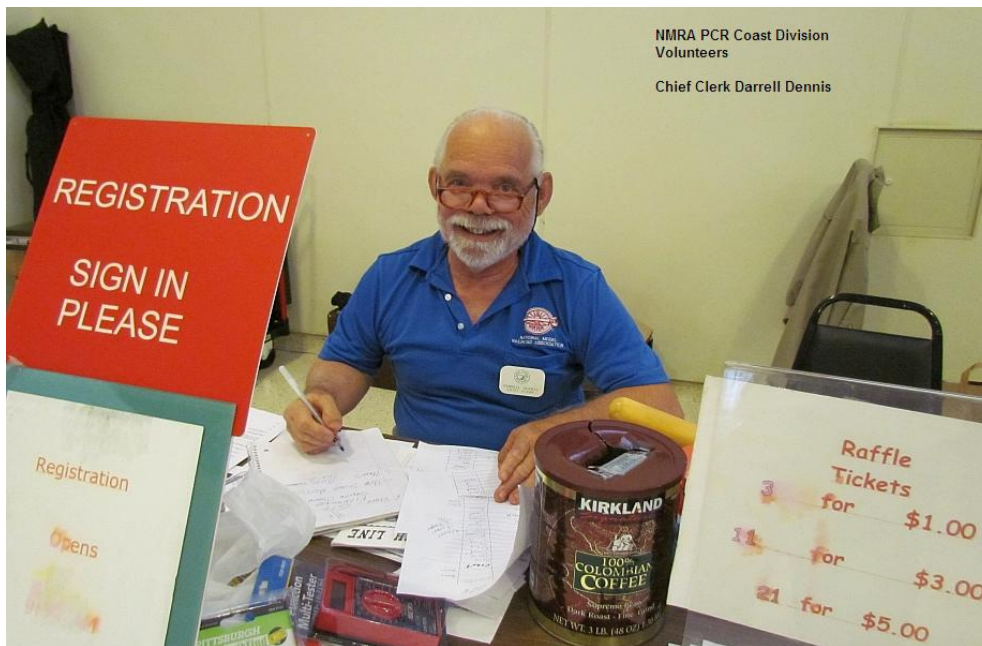

NMRA InfoNet

Here's all the news that's fit to print for October:

- In order to ensure the financial wellbeing of the NMRA into the future, there will be a [dues increase on January 1, 2012 for U.S. members and overseas members served by the Chattanooga office](#). Regular memberships will increase by \$5 to \$44, and subscriptions to *NMRA Magazine* will increase by \$3 to \$22. Sustaining memberships (including the magazine) will increase by \$13 to \$110, and student memberships (including the magazine) will increase by \$4 to \$32. In addition, our highly successful RailPass trial membership program will continue at \$9.95. The current RailPass conversion rate to regular memberships is around 65%. [Memberships administered by the A, B, and C offices are not affected.](#)
- Di Voss, who's heading up the Cruise Convention committee, continues to receive [results from the survey published in the October issue of NMRA Magazine](#). To date he's received around 200 responses, and estimates those "in favor" to be about 75%. In addition, Di would like to remind those who think there won't be enough time on a Cruise Convention for layout tours, OPSIG meets or other activities, that the ship will be in port from about 8:00 a.m. until about 10:00 p.m.
- For some reason, the story that the NMRA membership has been declining over the past few years continues to persist. IT AIN'T TRUE. [NMRA membership is holding steady](#) at around 19,500. According to the latest "Membership Thermometer" figures compiled by Marketing, Advertising and Promotions manager Tom Draper, the NMRA lost 104 members between August 2009 and August 2011, but gained 91 members between August 2006 and August 2011. Please help us set the record straight by mentioning this to your membership!

Convention news: Even though Grand Rails 2012 will have dozens of top notch model railroads open for self-guided tours, the convention committee wanted to make sure everyone has a chance to see some of their great layouts. So there will also be [several bus tours to some of the area's best layouts](#). Layouts include every scale from Z to G, and every level of completion. They're also offering a very special, exclusive seven-hour limo layout tour for groups of 6 to any of the six layouts on the self-guided list. The price for the limo is only \$120 per person. 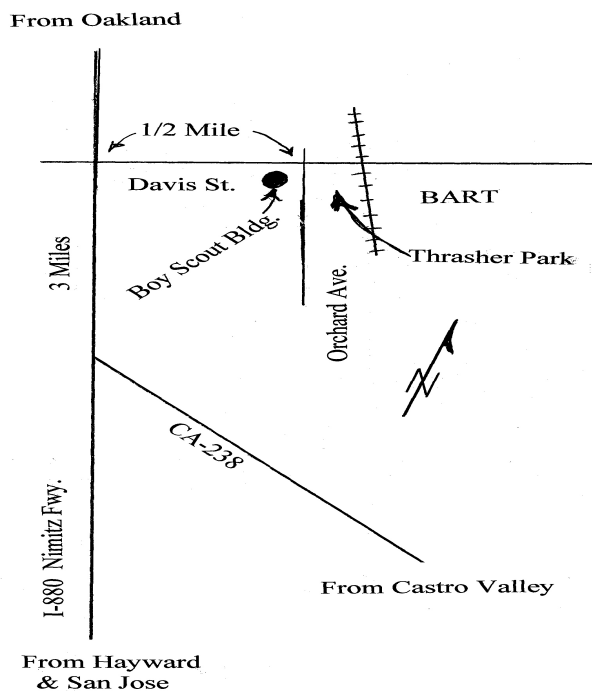
