E. APPROVAL OF THE MINUTES OF THE PREVIOUS BOARD MEETING

- F.2. Vice-President Alexander provided an oral report. She said she is currently working on two projects, which include revising the Convention Manual and revising our Region's logo. More detailed information about those projects will be included later in the meeting.
- F.3. Treasurer Coen submitted a written report that I attached to the record copy of these minutes. In addition to the written report, the Board discussed the issue of how to charge the cost of "Formsite.com." The issue is whether the cost of Formsite.com is charged to the Convention Committee alone as a cost of doing business or as a recurring expense to PCR. Treasurer Coen will follow-up with Director Grenier to clarify the uses of the program and where we might best charge the expense.

H.1. Administration Department

• Because the PCR had a change in Treasurer, an audit will need to be conducted. President Merrin will contact the Audit Committee to have this performed before the next Board of Director's meeting.

- President Merrin is going to pursue an update on National's efforts to create an organization under IRC 501(c)(3). No action will be taken to form an IRC 501(c)(3) at the regional level.
- There are a number of vacancies in the Region, and we will work on filling them.
- Honors Committee Chariperson deBlieck provided a spreadsheet that listed the Region's honors positions, the names of the recipients, and when they were awarded. This list is attached to the record of these minutes.

H.2. Membership Department

Membership Department Manager Doug Wagner submitted a written report, which is attached to the record copy of these minutes.

H.3. Publications Department

There was no written report submitted.

H.4. Convention Department

There was no written report submitted, by Manager deBlieck gave a full verbal report. In his report he discussed future convention issues and the status of a potential joint convention with the PSR, which is discussed in more detail in Old Business.

H.5. Contest Department

There was no written report submitted.

H.6. Achievement Department

H.7. Non-Rail Department

There was no written report submitted.

I. OTHER REPORTS

There were no other reports.

J. OLD BUSINESS

J.1. Correction to section 13.B.4. of the Manual of Operations.

Secretary Swearingen was directed to correct the Manual of Operations, Section 13.B.4, to read "...by mid-February of odd numbered even-numbered years." This correction will reflect current and past practice.

J.2. Filling Store Keeper Position

This is a vacant position that still needs to be filled.

J.3. Changing the convention rotation to reduce the frequency of Coast Division as host

- The Coast Division is asking that the Region change the rotation so that the responsibility for holding the convention does not rest with the Coast Division every other year. Many people in Coast are very busy with other events in the Coast Division, and this is proving to be too much for the Division to do. Reducing the frequency of Convention responsibility will also help the individual members who are hosting layout tours and operation sessions.
- Any Division hosting a convention is not solely responsible other Divisions can and do help out.
- Motion made by Director Schutzer "Change the convention rotation to once every four years for each division, with the following prospective conventions for the next four years as follows:
 - 1. 2017 Daylight
 - 2. 2018 RED
 - 3. 2019 Sierra
 - 4. 2020 Coast

Motion second from Director Croshere; Motion approved.

- J.4. Status of Convention Manual update by Vice-President Alexander and Convention Department Manager DeBlieck
 - Vice President Alexander Convention Department Manager deBlieck, Tom Crawford, and Jim Long left a lot of valuable information for the committee. It was very thorough. The old manual had language that was written with language that commended specific actions. It is being revised with language that is more permissive, such as "could" or "should" versus "shall." The revision thus far has reduced the number of pages to about 300. Duplicated information is being removed. Expect a much smaller book. Carol appreciated all who have worked on it. In six to eight weeks she hopes to have something for everyone to review.
- J.5. Status update on the PCR logo revision
 - Vice President Alexander passed around sheets with an image that the subcommittee has been working on. Everyone present commented positively on the proposed logo. It combined elements of each Division: mountains for the Sierra Division, Redwood trees for Redwood Empire Division, the Tehachapi loop for the Daylight Division, and water for the Coast Division.
 - President Merrin directed Vice President Alexander to proceed with changing the font in the logo to Sans Serif, and to explore technical issues with production of new logo by contacting someone who can produce the logo in various sizes.
- J.6. Do we want to combine the 2019 PCR, our 75th anniversary, with the PSR?
 - There is no actual agreement with PSR, only exploratory talks. The Board feels positively about doing this in principle, but the dates offered by PSR

are not acceptable. There are issues to be resolved, including finding dates that are acceptable to both and how to structure the agreement with regard to various potential conflicts. Convention Department Manager deBlieck will continue to explore the issue.

- J.7. Update on membership fee sharing between Division, Regional, and National
 - Director Croshere reviewed this item, which is a recruiting tool. The proposal to National was as follows: If we find someone young who might be interested in being a member of PCR, but who may be unable to pay for membership, could PCR split the membership fee with national paying 50%, Regional 25%, and Division 25%?
 - At the end of the last PCR Board meeting Director Croshere and RAC Jack Hamilton would explore this. Director Croshere provided the information to RAC Hamilton from National, and now Director Croshere is waiting to hear from RAC Hamilton about what the next steps would be.
 - President Merrin volunteered to contact RAC Hamilton to get the status from National.

K. NEW BUSINESS

- K.1. Digital Projector Policy
 - We recently had to replace a projector lost at the convention in Newark, and there was lack of clarity about who should pay for replacing it. This is the second projector lost; in the first case the Division paid, in this case the Convention paid. In order to have a clear policy in place for future losses or damage to projectors, Vice President Alexander made the following motion:

"The responsibility for replacement or repair of region equipment will be born by the custodian organization at the time of loss or damage. Extenuating circumstances may be appealed to the PCR Board." Second by Director Schutzer; Motion approved.

- K.2. How can we reduce the time it takes to report certification of officers and directors to National?
 - Secretary Swearingen will download the forms from NMRA website and send out to each Director after elections.
- K.3. Can the PCR sponsor the West Side Reunion on April 16, 2016?
 - President Merrin circulated a flier for the West Side event.
 - Motion made by Director Schutzer "The Pacific Coast Region will cosponsor the West Side Reunion in 2016, as long as no cost accrues to the PCR." Second by Director Croshere; Motion approved.
- K.4. Superintendents don't get credit for AP as the Regional elected officers do, even though they actually do more work than the Directors. Board members felt this wasn't right. President Merrin will pursue this issue with

the appropriate Regional and National officials who are responsible for the AP program.

L. ANNOUNCEMENTS

- L.1. Convention Department Manager DeBlieck every single PCR officer position changed this year. The last time this happened was in 1957.
- L.2. Vice-President Alexander announced that she is moving to Pennsylvania next summer, and will not be able to finish her tenure as Vice President. However, she is committed to finishing the logo and convention manual before leaving.
- L.3. The next Board of Director's Meeting will be on Wednesday, April 20, 2016, 1PM, Double Tree Hotel, 1150 9th Street, Modesto, CA.

M. ADJOURNMENT

Director Croshere made a motion that we adjourn the meeting. The motion was seconded by Director (by proxy) Harmon. Meeting adourned at 3:40PM.

President's Report October 10, 2015

To the Board of Directors:

The first six months of my term has been largely spent on getting organized and oriented, overseeing the filling of important vacancies, and assisting in PCR's support of the recent National Convention in Portland by providing materials (projectors and photo easels) for educational and contest activities as requested by the convention committee. Those things largely accomplished (with the exception of the vacant Storekeeper position) I spent some time reviewing materials and have set a few preliminary goals and issues. Some of them will be touched on in today's agenda, but not all. The list below is not in order of urgency or significance.

The Board spent quite a bit of time discussing the creation of a new logo. I personally did a lot of nagging and nudging about this because I believe it is so important to have a logo that gives the right impression to the modeling community. Hopefully we have made progress and are close to choosing a new and improved logo.

Relationships with non-NMRA organizations: Former President Pat LaTorres had put considerable energy into connecting with non-NMRA modeling groups, for instance serving as a liaison to the BAPM meet. In general, broadening our visibility in the modeling community (e.g., garden railroading, narrow gauge, European prototype, live steamers) should be one of our important goals and is one route by which our reputation and attractiveness to a younger demographic might be improved.

Pat has also served as our representative with 21st Century Limited. I intend to ask him to continue if he is able to give us periodic reports on anything relevant to PCR. I reviewed the articles of incorporation and bylaws of 21st Century Limited to familiarize myself with the organization if any questions arise for discussion.

Let's stop having Coast host every other year. That idea has run its course and we have burned out a bunch of good people. We initiated some discussion on this and we should proceed with doing something about it.

In Portland I met Steve August, now in charge of RAC. He is extremely energetic and passionate about RAC and actually liked the annual report I sent him (in fact, he said it was the best one!). He promised me that he would be calling us directly about RAC

matters. He has just distributed a summary of what Regions and Divisions are supposed to be up to and I will bring some copies to this meeting for anyone who is interested.

The PCR Call Board needs some updating and there are important positions vacant. I will be working on this and hope to have the corrections passed on so that our website is accurate.

I'm sure there's a lot more but this list is long enough. Expect me to do considerable delegating and I will be soliciting opinions and comments often.

Coast Division Report PCR Board Meeting – October 10, 2015 Modesto

The Coast Division held two successful meets in the time between the last Board Meeting. Our June meet was held at Boy Scout headquarters in San Leandro and the September meet was held at the Elks club in Alameda.

We seem to have resolved the issue of meeting sites in the short term. We now have two stable sites, the BSA HQ and the Alameda Elks club that we can alternate between. The rebuilding of the multipurpose room at Buchser School is complete and that site may again be viable. While we are always looking for more meeting sites having a couple of stable sites makes things a lot easier

Attendance at the meets is in the range of 80 to 100 people. The Coast Auction has had 400 to 500 items the last couple of meets so it is covering the cost of the meet and making some positive income. Since the change to an electronic dispatcher a few years ago the financial situation continues to be in the black as the income from the meets exceeds our expenses. The Coast Division has something in the area of \$24.5k in the bank account.

Steve Wesolowski and Frank Markovich continue to lead a team of volunteers manning the NMRA table at all the local train shows and events. Frank and Mike Blumensaadt also bring the "build a memory" layout to the shows demonstrating hands on how to build a layout. We continue to several new guests / members at each Coast Meet.

The Daylight Division held just one meet since the last Board of Directors meeting in May. Our Spring Meet, usually held in May, was moved up to April 25 because of the PCR Convention in mid-May. As was previously reported, it was annulled when the venue locked its doors 2 weeks before the meet.

The Summer Meet was held on a very pleasant Saturday, August 1, at the historic Oceano Depot in Oceano. I say "pleasant" because while the temperature in the San Joaquin Valley had been in the 100s for many days, the forecast high temperature for Oceano was cooler than when I left Clovis at 6:00 AM! The lower temperature was most welcomed by our members coming in from the Valley. Our co-hosts for the day were the Oceano Depot Association and the San Luis Obispo Model Railroad Association (SLOMRA). Daylight member George Gibson organized and coordinated the day's events and activities. Thirty-eight members and guests from all over the Central Coast area joined us.

The meet started with the usual sign-ins, refreshments, contest entries, and lots of socializing. The first of two clinics was presented by SLOMRA President Phil Lawyer on power protection and voltage loss for layouts and modules. George Gibson followed up with a clinic on installing flicker-free lighting in passenger cars and cabooses. After enjoying a lunch of Santa Maria Tri-Tip sandwiches and all the trimmings cooked by the Oceano Depot Association, we had a short business meeting to pay the bills and present Doug Wagner with his Daylight Division Member of the Year award, concluding with the raffle and the world-famous Daylight White Elephant Auction.
